

Deposit & Damage Waiver

Your protection options : Bronze, Silver or Gold



The minimum level of cover for your cruise is our basic insurance plan (see Bronze Protection below).



Bronze – Limited Protection (included in your booking)

- This is the minimum level of cover required for your cruise.
- In case of damage, there is an excess of 2500€ to 3500€, depending on the type of boat (not including the exclusions from insurance cover).
- This excess will be blocked as a deposit on the first day of your cruise (via credit card pre-authorization or french cheque).

For added peace of mind, we offer two optional protection upgrades that significantly reduce – partially or entirely – your financial liability in the event of any damage to the boat and its equipment.



Silver – Intermediary Protection

- The amount of this option varies from 130€ to 180€ depending on the type of boat.
- In case of damage, an excess of 600€ to 800€ now applies, depending on the type of the boat (not including the exclusions from insurance cover).
- This excess will be blocked as a deposit on the first day of your cruise (via credit card pre-authorization or french cheque).



Gold – Complete Protection

- The amount of this option varies from 230€ to 280€ depending on the type of boat.
- In case of damage, no excess now applies (not including the exclusions from insurance cover).
- A minimal deposit of 600€ will be blocked on the first day of your cruise (via credit card pre-authorization or french cheque), to cover any potential additional fee (paying extras, fuel, exclusions from insurance cover, etc ...).

Good to know :

- You can add or change your protection up until the day of the start of your cruise.
- Once the cruise has begun, the selected protection cannot be changed.
- As with any insurance policy, certain exclusions apply (see verso for more details).

subscribes to the « Silver » protection (**excess reduced to 600€ to 800€** depending on the type of boat, not including the exclusions from insurance cover). The deposit is equal to the excess.

subscribes to the « Gold » protection (**excess reduced to 0€**, not including the exclusions from insurance cover). A minimal 600€ deposit stays mandatory at departure, to cover any expance listed in the exclusions from insurance cover.

Exclusions from insurance cover

The following items, referred to as « Exclusions », are not covered by the boat insurance nor the Silver or Gold damage waivers. In the event of damage to the rented boat or damage caused to a third party or property under any of these exclusions, the hirer remains financially liable and must pay for the total amount of damage.

List of exclusions from the damage waiver :

- Breach of navigation rules (e.g. navigating outside authorised areas, at night, not following priority rules, not respecting lock instructions or timetables).
- Violation of rulings, navigation restrictions
- Violation of instructions given by our teams.
- Driving while under the influence of alcohol, drugs or substances (even medicinal ones) that affect consciousness or the ability to react.
- False statement.
- Deliberate damage to the boat and any malicious act committed by or with the complicity of any person on board.
- Criminal or inappropriate use of the boat, its equipment or accessories.
- Use of the boat for purposes other than personal pleasure.
- Exceeding the authorised number of passengers by the hire company.
- Damage to the bimini awning or convertible awning (canvas and/or frame).
- Boat abandonment fees.
- Delay in returning the boat.
- Intervention following a blockage in the toilets caused by the crew.
- Loss, theft or damage to hired bicycles, or any other optional equipment hired at the same time as the boat (barbecue, wi-fi box, etc ...)
